RULES

- 1** **Entries** will be open to certified adult members of the USBC. Teams will consist of three (3) members any mix. No team will be allowed to have more than one PBA cardholder on the team.
- 2** **Handicap** will be based on 100% of 220. There will be no limit on handicap.
- 3** **Multiple Entries:** Re-entry will be allowed if lanes are available, but at least one player in the lineup must be changed.
- 4** **Entering Averages:** Averages will be based on the highest average of the 2019-2020 bowling season of 21 games or more (per [bowl.com](http://bowl.com)). If average is not available, bowlers will be allowed to bowl, but must bowl scratch. Any bowler falsifying their average will be disqualified. **Team average will be CAPPED at 660. (The Difference between team average and 660 will be deducted from their final score).** **RERATE:** The tournament committee reserves the right to rerate the average of any bowler whose average does not reflect their true ability, USBC Rule 319C, USBC Rule 319d (Tournament Prize Winnings) and USBC Rule 319a-3 (Bowlers responsibility) will apply.  
USBC Rule 319a-2 (10 pin rise rule) and USBC Rule 319e (Average Adjustment for Entry) will not apply.
- 5** **ENTRY FEE:** Entry fee will be **\$75.00 per team:**

\$27.00	Bowling
\$ 3.00	Expense Fees
\$45.00	Prize Fund

**Entry fees must accompany entry forms. No refunds once entry has been accepted.**
- 6** All prize fees will be paid out 100%; one (1) in ten (5) prize ration will be utilized.
- 7** **ENTRY DEADLINE:** All tournament entries will close 20 minutes prior to the last shift on May 16, 2021. Due to the limited availability all entrants are encouraged to enter in advance of the tournament, however, entries will be allowed up to the entry deadline if space is available.  
**TARDY BOWLERS:** Tardy bowlers shall begin tournament play with the score to count from the frame they begin to bowl.
- 8** There will be only a one lane courtesy in effect in this tournament.
- 9** There will be a **\$15.00** check charge for any returned checks, no exceptions.
- 10** Pacers will not be allowed.  
The following is not permitted while the tournament is in progress:  
NO FOOD OR DRINK is allowed in the bowling area.  
Bowlers are expected to behave in a mature manner and show good sportsmanship.
- 11** **PROTESTS:** Decisions of the tournament management shall be final unless an appeal is made in accordance with USBC Rule 329.
- 12** USBC Rules and Regulations shall govern any rule not covered above.
- 13** *COVID-19, Tournament participants will be required to follow bowling center, local, and State Current Guidelines.*

**To all who enter:** Premature termination of the tournament brought about by war, national emergency or emergency cause relating thereto or there from, fire natural disaster or any other reason beyond the control of the Gr. Johnson City USBC Association shall cause, to the extent required thereby, all prizes, guaranteed or otherwise, to be prorated in accordance with the number of entrants who have bowled up to the time of such termination.
