MIXED TRIO TOURNAMENT RULES

1 **Entries** will be open to certified adult members of the USBC. Teams will consist of three (3) members any mix (example MMM, FFF, FMF & MFM). No team will be allowed to have more than one PBA cardholder on the team.

2 **Handicap** will be based on 100% of 230. There will be no limit on handicap.

3 **Multiple Entries:** Re-entry will be allowed if lanes are available, but at least one player in the lineup must be changed.

4 **Entering Averages:** Averages will be based on the highest average of the 2022-2023 bowling season of 21 games or more (per bowl.com). **If average is not available, bowler may use current highest average of 21 games as of May 1, 2024 with verification, if neither must bowl scratch.**

Any bowler falsifying their average will be disqualified. Team average will be CAPPED at 690.

RERATE: The tournament committee reserves the right to rerate the average of any bowler whose average does not reflect their true ability, USBC Rule 319C, USBC Rule 319d (Tournament Prize Winnings) and USBC Rule 319a-3 (Bowlers responsibility) **will apply.**

USBC Rule 319a-2 (10 pin rule) and USBC Rule 319e (Average Adjustment for Entry) **will not apply.**

5 **ENTRY FEE:** Entry fee will be **\$99.00 per team:**

\$36.00	Bowling
\$ 6.00	Expense Fees
\$57.00	Prize Fund

No entry form will be accepted without entry fees. Also, all entry fees must be accompanied with complete entry forms or priority will be forfeited. REFUNDS: No team or individual shall be entitled to a Refund after the entry fees have been received and definite dates assigned. USBC Rule 314

6 All prize fees will be paid out 100%; one (1) in five (4) prize ratio will be utilized.

7 **ENTRY DEADLINE:** All tournament entries will close 20 minutes prior to the last shift on May 21, 2024. Due to the limited availability all entrants are encouraged to enter in advance of the tournament, however, entries will be allowed up to the entry deadline if space is available.

TARDY BOWLERS: Tardy bowlers shall begin tournament play with the score to count from the frame they begin to bowl.

8 There will be only a one lane courtesy in effect in this tournament.

9 There will be a **\$25.00** check charge for any returned checks, no exceptions.

10 Pacers will not be allowed.

11 **No one may bowl in this tournament except those originally entered before entries close or such replacements authorized by the team captain or their appointees. All replacements must qualify with the Tournament Rules and the captain will be responsible for the verification of their tournament average. No changes in the team lineup will be permitted except in the case of replacements. A replacement will bowl in the same position as the bowler replaced. USBC Rule 324**

The following is not permitted while the tournament is in progress:

NO FOOD OR DRINK is allowed in the bowling area.

Bowlers are expected to behave in a mature manner and show good sportsmanship.

12 **PROTESTS:** Decisions of the tournament management shall be final unless an appeal is made in accordance with USBC Rule 329.

13 USBC Rules and Regulations shall govern any rule not covered above.

To all who enter: Premature termination of the tournament brought about by war, national emergency or emergency cause relating thereto or there from, fire natural disaster or any other reason beyond the control of the Gr. Johnson City USBC Association shall cause, to the extent required thereby, all prizes, guaranteed or otherwise, to be prorated in accordance with the number of entrants who have bowled up to the time of such termination.
